

Privacy Policy

This Privacy Policy explains how **AuthWall** ("we", "our", "us") collects, uses, and protects your information when you use the AuthWall mobile application (the "App"). We are committed to safeguarding your privacy and ensuring transparency.

By using the App, you agree to the practices described in this Privacy Policy.

1. Information We Collect

AuthWall is designed with a **privacy-first approach**. We collect only the minimum information necessary to operate and improve the App.

1.1. Information You Provide

We may collect the following information when you interact with the App:

- Email address (only if you contact us via support)
- Crash reports or diagnostics (optional, if enabled by your device settings)

The App does **not** require you to create an account.

1.2. Automatic Information

Depending on your device settings, we may automatically collect:

- Device type and OS version
- App version and usage data
- Anonymous analytics (if enabled)

We do **not** collect personal identifiers such as your name, phone number, or address.

1.3. Sensitive Security Information

To provide the App's security-related functionality:

Two-Factor Authentication (2FA)

- The App stores your authentication secrets **locally on your device only**.
- We do **not** collect, store, transmit, or access your 2FA keys or codes.

Email & Login Leak Analysis

- Your email address is processed **locally** for sending to breach databases.
- We do **not** store your email or login credentials.
- We do **not** access your passwords.

Wi-Fi Security Analyzer

- Wi-Fi network metadata (SSID, encryption type, security level) is processed **locally**.
- We do **not** collect or store your network traffic.
- We do **not** collect MAC addresses or device identifiers.

AI Security Assistant

- Queries you send to the AI assistant may be transmitted to our AI service provider for processing.
 - These queries may include security-related information you choose to share.
 - We do **not** store AI queries unless needed for debugging or improving the service.

2. How We Use Your Information

We may use collected information for the following purposes:

- To operate and improve the App
- To diagnose technical issues
- To provide customer support
- To enhance safety and security features
- To comply with legal obligations

We do **not** use your data for:

- Advertising
 - Tracking you across apps or websites
 - Selling or renting your data

3. How We Store and Protect Data

Your security is our priority.

3.1. Local-Only Storage

- 2FA keys and Wi-Fi scan data are stored **locally** on your device.
- Removing the App permanently deletes this data.

3.2. Cloud Storage (If Applicable)

We do not store personal data in the cloud unless you explicitly send us information via:

- Customer support email,
- Diagnostic logs.

3.3. Security Measures

We implement industry-standard protection:

- Encryption in transit (TLS)
- Secure local storage methods
- Restricted employee access

No system is 100% secure, but we take all reasonable steps to protect your information.

4. Data Sharing and Disclosure

We do **not** sell, rent, or trade your personal information.

We may share data only in the following cases:

4.1. Service Providers

We may share limited technical information with trusted partners who help us:

- Provide AI processing
- Analyze performance
- Improve stability

Partners are contractually obligated to protect your data and comply with GDPR/CCPA where applicable.

4.2. Legal Requirements

We may disclose information if required by:

- Law enforcement
- Government authorities
- Court orders

We will only provide the minimum necessary information.

4.3. Business Transfers

If AuthWall is acquired or merged, non-sensitive operational data may be transferred. 2FA keys, Wi-Fi data, and leak analysis data are not stored by us and therefore cannot be transferred.

5. Your Privacy Rights

Depending on your region, you may have rights under GDPR, CCPA, or other laws, including:

- Right to access your data
- Right to correction
- Right to deletion

- Right to restrict processing
- Right to withdraw consent

6. Children's Privacy

The App is not intended for children under 16 years of age. We do not knowingly collect personal information from children. If you believe a child has provided us data, please contact us.

7. International Transfers

If you are located outside our primary operational region, your data may be processed in other countries. We ensure such transfers meet all applicable legal requirements.

8. Third-Party Services

The App may use third-party tools, such as:

- AI processing APIs
- Analytics tools
- App store payment systems

Each third-party service is governed by its own privacy policies. We encourage you to review them.

9. Data Retention

We retain data only as long as necessary for the purposes described in this Policy.

We do not retain:

- 2FA data
- Wi-Fi scan data
- Email/password information from leak checks

These remain solely on your device.

We may update this Privacy Policy from time to time. Changes will be posted within the App with an updated "Last Updated" date. Continued use of the App means you accept the updated Policy.
